Open Enrollment - Sign up for health care coverage on MD Health Connection by Dec. 15

Dear Friend,


Happy Holidays to all my wonderful constituents in Maryland's 8th District! I am writing to remind you that if your employer doesn't provide health care coverage, **you can purchase, renew, or change your health insurance plan** through [Maryland Health Connection](#), our state's official health insurance marketplace, **through December 15th, 2018.**

Maryland Health Connection seeks to provide quality health insurance coverage that fits your budget. When you apply for coverage, you may also qualify for financial help, such as tax credits, cost sharing reductions, or even free or low-cost coverage. During last year's enrollment period, nine in 10 people who enrolled through Maryland Health Connection qualified for some form of financial assistance.

Note: You must enroll by December 15, 2018, in order to have coverage begin on January 1, 2019.
